## Research Proposal Requirements

Ref. No.: Research proposal shall comprise of the following (10-15 Pages) details **Date :**

- a) Cover page mentioning the applicant's name, title/topic and relevant details (contact details), declaration on plagiarism (For example, I hereby declare that this is my original work, concept and writing) with signature.
- b) Abstract (Maximum 300 Words)
  - i) An introductory sentence or two on the broad theme of the paper
  - ii) What is the theoretical framework of the paper (E.g. Post colonialism or realism)?
  - iii) Whether the paper is doctrinal or empirical? If empirical, then what will be the specific methods used for the paper?
  - iv) In a sentence or two, write the sub-themes or sub-sections of the paper.
- c) Background of the Study
- d) Research Questions
- e) Objectives of the Study
- f) Rationale of the Study
- g) Limitations of the Study
- h) Methodology (Clearly mentioning Qualitative and/or Quantitative methods)
- i) Literature Review- Identification of Literature Gaps and how the present study would fill the gaps
- j) Sub-themes of the paper
- k) Detailed Bibliography

Bibliography shall consist of the primary and secondary sources available in the area of study. It should be broad, consisting of books, articles, case law and other materials that would be used for the paper. Use KSL Comprehensive Style Guide for citation style- [https://kslreview.org/public/journals/5/images/Style\\_Guide\\_KSLR\\_Ebook.pdf](https://kslreview.org/public/journals/5/images/Style_Guide_KSLR_Ebook.pdf)

- Application can be made individually or in group not exceeding three members in total.
- The recipient of same grant in the last two years is not eligible to apply this year.
